

AIS AGREEMENT

AIS REPRESENTS THE PRE-ADOPTIVE PARENT BY PROVIDING EDUCATION, REFERRALS, ADVOCACY, ASSESSMENT AND SUPPORT SERVICES.

Clients of AIS will benefit in the following ways:

- Education and guidance regarding procedures, general adoption process in different states, the home study process and networking strategies.
- Relationships with adoption agencies and attorneys in adoption friendly states and average placement times are less than 12 months.
- Direct referrals regarding specific expectant mothers through licensed adoption agencies and attorneys without any upfront fees.
- Support from AIS Staff who are adoptive parents and understand the emotions involved in the process.
- Adoptive Parent Profile preparation assistance.
- Assist in the assessment of risks involved in medical and/or social information of expectant mothers and provide referrals to other resources when appropriate.
- Ongoing advice and guidance through your adoption process.

\$4,200 SERVICE FEE PAYABLE AS FOLLOWS*:

- **\$400 application fee due prior to first appointment**
- **\$1,900 paid at first appointment**
- **\$1,900 paid at second appointment**
- **There is no charge for your third appointment**

Your service fee includes three private counseling sessions as well as telephone and email contact through the first 12 months of your process beginning when you become an active client of AIS. Continuing advice, guidance and direct referrals beyond 12 months are available on a fee basis. If you are matched with an expectant mother through our referral services prior to completing the second appointment, then the final payment of \$1,900 will be due immediately. The second and third appointments may then be cancelled or held at your discretion.

We understand that AIS reserves the right to terminate our Agreement at any point and without refund of any fees paid if it is discovered that we

- withheld information about our background and history on our application that is later disclosed through the home study process or other means Initials _____ Initials _____
- changed our tolerances and/or preferences from our original application and misrepresented our desires for the child we would like to adopt ; i.e.: gender preference, race preference, tolerances of expectant mother or father medical or social backgrounds, legal risk issues
